- › Make sure you fill in all the boxes that apply to you. Tenancy Services will be unable to release the tenants' portion of the bond until all tenants have signed the form and indicated how much each tenant is to receive.
- › If your bond was lodged on or after 2 December 2024, please include the signature page of your tenancy agreement when you send us this form. We use this to verify the signatures on this form.
- › If you are using a pen to fill in this form, please print clearly. Do not sign this form until all information has been entered.

Personal information provided on this form will be held and used by the Ministry of Business, Innovation and Employment for the purposes of administering and enforcing the Residential Tenancies Act 1986. It may also be used for carrying out customer surveys, public education and statistical analysis. We may occasionally provide your information to third parties to carry out this work on our behalf.

The personal information you supply will not be used for any other reasons unless permitted under the Privacy Act 2020 (for example, with your consent or for a directly related purpose). The information may also be provided to third parties where it is required or permitted by law.

The personal information you supply will be provided to all parties named on this form or on the bond record.

If you are providing someone else's bank account details on this form, you should get their consent.

Address information

By providing us your contact details you are authorising Tenancy Services to contact you.

We collect this information so we can contact you about this bond and minimise any delays in paying out/ refunding the bond when the tenancy finishes.

If you provide an email address, we will use this as the primary way to contact you.

Date tenancy ended

It is important that you include the date the tenancy finished, as agreed between the tenant and the landlord. This date can affect the way the bond is paid out.

Refund details

This section shows how you have agreed the bond money will be paid out to the tenant, landlord or both. The money will come from the general bond, the pet bond, or both. If the landlord wishes to claim some or all of the bond money, they must indicate the reason why using the tick-boxes. If there is any amount that you cannot agree on, this should be written in 'Amount on hold'. This amount will not be paid out until agreement is reached or until a mediated/Tenancy Tribunal order is made.

If your bond was lodged on or after 2 December 2024, please include the signature page of your tenancy agreement when you send us this form. We use this to verify the signatures on this form.

Landlord refund details: The landlord(s) should complete this section.

Landlord ID number: If you do not know this number, leave the box blank.

Tenant refund details: The tenant(s) should complete this section.

You can provide any NZ bank account. For example, your new landlord, if you want your refund portion to be paid directly to them. You should get their consent first. If you are refunding your portion to the bank account of your new landlord, put your initial and surname in the reference field of this form. This is located next to the bank account details.

Definitions

Bond number: This is the bond number for the tenancy address. One bond number can cover a general bond, a pet bond, or both. There are not separate bond numbers for each type of bond. It is on all our letters to you about this rented property. If you do not have it please contact us.

Reason for refund

Tenant leaving: at least one tenant on a multi-tenanted tenancy is leaving and some of the bond is to be refunded.

Decrease in rent: some of the bond is to be refunded to parties because of a decrease in rent.

Partial refund: some of the bond is to be refunded to parties. This box can be used when you only want the pet bond refunded.

Disposal of goods: money received through disposal of goods is refunded to the parties.

Tenancy ending: all tenants are leaving the tenancy.
